Terms and Conditions

I understand and agree to the following terms and conditions:

1. I acknowledge that the Swedish School Society (The Nordic School) is a parent-run school. As a parent/guardian, I am expected to actively participate in and contribute to the children and the school, as well as foster a positive environment.
2. I agree to support the principles of the school as outlined on its official website.
3. I agree to pay the school fees by the specified deadline. Penalty fees for late payment may apply. I understand that if I have any outstanding debt to the school from a previous term, my child may not be permitted to return to school and may risk losing their place.
4. I agree to collect my child within the chosen and designated time slot. If I am unable to do so, I will notify the teachers by phone. I understand that if I am late more than three times in a month without prior notice, a fine may be imposed.
5. If I have given consent for the school to use pictures or videos of my child for publications, social media and marketing purposes, I understand that these materials may be archived at the school and used for future promotional purposes without further notification.
6. If I have not given consent for the school to use pictures or videos of my child for publications, social media, or marketing purposes, I understand that images or videos of my child may still be taken for internal use only—for example, in the monthly newsletters.
7. I acknowledge that the school reserves the right to determine the most appropriate group placement for my child based on their age and developmental needs, while also considering the needs of the groups.
8. I understand that it is my responsibility to provide personal accident insurance and coverage for the loss of personal belongings, as the school does not provide insurance for children participating in school activities.
9. I confirm that I have been informed about the swimming facilities on the premises and give permission for my child to participate in supervised swimming classes as part of the regular
